

Message from Caylin Wade, President, TCB

The International Dyslexia Association of Southern California Tri-Counties Branch's main mission includes promoting and disseminating research-based knowledge about effective teaching methods for all students in K-12 schools, as well as in other types of settings; increasing awareness of dyslexia and related learning difficulties; and assisting all professionals who work with persons who have dyslexia, students and persons with dyslexia, and their families, until all can read.

As a board of directors we plan and implement many webinars and other activities each year that are of interest to professionals in many fields, students, families, and anyone with dyslexia. We disseminate news to our membership that including updates on legislation both at the state and federal levels, school district -based research findings, as well as current news from the California Department of Education.

We also provide a list of trained clinicians, tutors, and parent advocates for the three counties: Orange, Riverside and San Bernardino. Additionally, we disseminate information requested via several methods including social media. Our support of the community includes providing information to a number of resources available to families and educational professionals. Finally, we partner with related professional fields in hosting seminars for teachers, school psychologists, speech therapists, teachers, administrators, parents and persons with dyslexia.

As a branch of IDA we adhere to IDA's mission that includes the belief *"that all individuals have the right to achieve their potential, that individual learning abilities can be strengthened and that social, educational and cultural barriers to language acquisition and use must be removed. The IDA actively promotes effective teaching approaches and related clinical educational intervention strategies for people with dyslexia. We support and encourage interdisciplinary research. As part of IDA we facilitate the exploration of the causes and early identification of dyslexia and are committed to the responsible and wide dissemination of research-based knowledge."*

Originally scheduled for April 2020, we were able to hold a successful conference emphasizing the challenges of reading for people with autism on April 10, 2021. We used a virtual conference platform that allowed participants from all over North America to participate.



The keynote speaker was Dr. Peter Mundy, Distinguished Professor of Education and Lisa Capps Chair in Neurodevelopmental Disorders and Education at UC Davis. The title of his talk was “The Difficulties of Autism Spectrum Disorder & Dyslexia.” This was followed by breakout sessions geared to teachers, parents, speech pathologists and psychologists/physicians.

Continuing education opportunities were available for teachers, speech pathologists, and medical professionals.

Outreach: Webinars, Workshops, and MORE!

TCB engages the community in many ways.

Ten free webinars were held during 2021. Over 1000 attendees from throughout the United States and beyond attended.

Not every walk was held at a dash pace!





We continue to receive & respond to an ever-growing number of important & interesting inquiries on a wide range of dyslexia-related issues, thus consolidating IDA's increasingly relevant position as the source for all things related to literacy — we are the “go-to-source for dyslexia”.

The IDA supports efforts to identify dyslexic individuals at an early age and provide them with appropriate instruction. The IDA believes that multisensory teaching and learning is the best approach currently available for those affected by dyslexia. The IDA does not endorse any specific program, speaker or instructional materials noting that there are a number that present the critical components of instruction as defined by the Task Force on Multisensory Teaching which works under the guidance of the IDA’s Teacher Education Issues Committee.

Importantly, IDA cautions parents who are looking for instructors, clinicians, schools, and programs to be very thorough in their review of programs and services that claim to treat dyslexia or “cure” dyslexia. In this era of internet advertising, claims are frequently made about therapies and treatment programs that have little or no scientific merit. Claims about the effectiveness of some widely advertised programs and/or their components may be unsubstantiated by objective, independent research, and the practitioners of those programs and methods may not have met customary standards for training in the field.
